

The Sixth Carbon Budget and Welsh emissions targets – Call for Evidence

Background to the UK's sixth carbon budget

The UK Government and Parliament have adopted the Committee on Climate Change's (CCC) [recommendation](#) to target net-zero emissions of greenhouse gases (GHGs) in the UK by 2050 (i.e. at least a 100% reduction in emissions from 1990).

[The Climate Change Act](#) (2008, 'the Act') requires the Committee to provide advice to the Government about the appropriate level for each carbon budget (sequential five-year caps on GHGs) on the path to the long-term target. To date, in line with advice from the Committee, five carbon budgets have been legislated covering the period out to 2032.

The Committee must provide advice on the level of the sixth carbon budget (covering the period from 2033-37) before the end of 2020. The Committee intends to publish its advice early, in September 2020. This advice will set the path to net-zero GHG emissions for the UK, as the first time a carbon budget is set in law following that commitment.

Both the 2050 target and the carbon budgets guide the setting of policies to cut emissions across the economy (for example, as set out most recently in the 2017 [Clean Growth Strategy](#)).

The Act also specifies other factors the Committee must consider in our advice on carbon budgets – the advice should be based on the path to the UK's long-term target objective, consistent with international commitments and take into account considerations such as social circumstances (including fuel poverty), competitiveness, energy security and the Government's fiscal position.

The CCC will advise based on these considerations and a thorough assessment of the relevant evidence. This Call for Evidence will contribute to that advice.

Background to the Welsh third carbon budget and interim targets

Under the Environment (Wales) Act 2016, there is a duty on Welsh Ministers to set a maximum total amount for net Welsh greenhouse gas emissions (Welsh carbon budgets). The first budgetary period is 2016-20, and the remaining budgetary periods are each succeeding period of five years, ending with 2046-50.

The Committee is due to provide advice to the Welsh Government on the level of the third Welsh carbon budget (covering 2026-30) in 2020, and to provide updated advice on the levels of the second carbon budget (2021-25) and the interim targets for 2030 and 2040. Section D of this Call for Evidence (covering questions on Scotland, Wales and Northern Ireland) includes a set of questions to inform the Committee's advice to the Welsh Government.

A. Climate science and international circumstances

Question 1: The climate science considered in the CCC's 2019 Net Zero report, based on the IPCC Special Report on Global Warming of 1.5°C, will form the basis of this advice. What additional evidence on climate science, aside from the most recent IPCC Special Reports on Land and the Oceans and Cryosphere, should the CCC consider in setting the level of the sixth carbon budget?

B. The path to the 2050 target

Question 5: How big a role can consumer, individual or household behaviour play in delivering emissions reductions? How can this be credibly assessed and incentivised?

ANSWER: Consumers, can play an enormous role in delivering emissions reductions. However, to date, engaging with them to take action on environmental issues, en masse, has been challenging. Barriers including cost, time and inconvenience, or knowing which actions to take, means 'Calls to action' often go unanswered.

However, recent advances in AI and Machine Learning, coupled with the rise of Big Data, means we have an opportunity to lower these barriers, and use the combined purchasing power of individuals to make substantial carbon cuts from consumer products and services – a sector responsible for 60% of global greenhouse gas emissions. In the UK alone, consumers use products and services with a combined carbon footprint of 176.4 MtC.

Last year saw the completion of 3 years of work by some of the UK's most prestigious organisations, designed to overcome one of the most important barriers to curbing global carbon emissions, namely: "Is it possible to calculate the carbon footprint of all consumer goods?" It culminated in Imperial College London, the project's expert academic partner, successfully devising an unprecedented method of calculating the carbon emissions of all consumer goods – everything we buy and sell – using Big Data and AI.

The goal is to create a mechanism capable of instantly calculating and ranking the carbon footprints of all consumer products, and making its algorithms freely available globally to entrepreneurs, businesses and institutions to incorporate into the products, services and applications they provide. The importance of this cannot be understated. For the first time, the detailed data on the sustainability of consumer goods will be made accessible for everyday use, facilitating a key step change in the way consumer goods are assessed and sold. When incorporated within applications such as e-commerce search engines or shopping sites the mechanism will, to an unparalleled extent, enable everyone whose goal is buying sustainable goods to use their purchasing power collectively to help mitigate carbon emissions. 1.66 billion people currently shop online. The potential for consumer-led emissions reduction is huge.

With its ability to rank goods according to their CO2 impact, the initiative can give companies real incentives to improve the sustainability of their products. They will have a new means of increasing their sales other than price: namely by improving their products' emissions, and consequently their rankings.

Question 6: What are the most important uncertainties that policy needs to take into account in thinking about achieving Net Zero? How can government develop a strategy that helps to retain robustness to those uncertainties, for example low-regrets options and approaches that maintain optionality?

C. Delivering carbon budgets

Question 9: Carbon targets are only credible if they are accompanied by policy action. We set out a range of delivery challenges/priorities for the 2050 net-zero target in our Net Zero advice. What else is important for the period out to 2030/2035?

ANSWER: With reference to Question 5:

Understandably, the range of delivery challenges and priorities set out in the Net Zero advice only touched upon ‘shifting consumer choices’ within the larger consumer sector. Focus was made on energy, efficiency, transportation, waste, diets and ‘energy behaviour’ (flying, etc). This is primarily due to the fact that, until now, the closest one could adequately get to using consumer purchasing decisions to reduce emissions, is by “choosing products that last longer and therefore improve resource efficiency”, or by using ‘point of sale in-use’ emissions figures.

This second option is often misleading. By way of illustration, a popular mid-sized 21.5-inch computer, showed its ‘point of sale’ power consumption as 62.20 kWh per year, with carbon emissions of just over 30 kgCO₂ per year. However, only through the time consuming and expensive task of manually footprinting the product, was it revealed that it has already clocked-up around 720 kg of CO₂ in production – twenty-four times its yearly ‘in use’ emissions. We believe that, by using AI and Big Data, we can employ a high level of automation to the task of footprinting, at a fraction of today’s cost and speed. A system could:

- Have the potential to calculate or estimate more accurately than any extant system the carbon footprint of any consumer product, and to instantly compare and rank goods within product ranges;
- Go far beyond any existing automated mechanism for calculating carbon footprints, by calculating or estimating the whole Life Cycle of consumer products;
- Have the capacity to incorporate other resource efficiency priorities within the algorithms in the future (water usage, toxins etc.);
- Be able to compare and rank products within price ranges, allowing consumers to buy the least ‘carbon intensive’ goods within their budget;
- Calculate or estimate emissions at any point in the supply chain of a given product;
- Estimate the ‘uncertainty of results’ that current manual approaches are not capable of revealing.

This would be an important addition to the delivery challenges for the period 2030/2035. For example, last year, discussions with the European Commission’s Cabinet for the Environment, raised the idea of how a ‘traffic light’ labelling system for CO₂ and other pollutants could be implemented on consumer goods via our mechanism.

Question 10: How should the Committee take into account targets/ambitions of UK local areas, cities, etc. in its advice on the sixth carbon budget?

ANSWER: Cities and regions are proving to be very ambitious with their plans for implementing carbon reductions. They also hold the key to one of the most important avenues available in curbing emissions, namely: procurement.

Public sector procurement is an area where Imperial’s work, and that of the growing

consortium that is coming together to deliver it, can help lead to huge carbon reductions. It is an enormous market segment whose remit is to respond to the ever growing demands of resource and energy efficiency. Every year, over 250,000 public authorities in the EU spend around 14% of GDP on the purchase of services, works and supplies.

By integrating the mechanism into procurement platforms and instruments, we can give governments and public authorities an easy and transparent solution to judging the comparative emissions of the goods they purchase. This means energy- and carbon-efficient goods, despite many having higher upfront costs, could enjoy a competitive advantage, thanks to their strong sustainability performance.

With the implementation of our initiative we can reduce overall energy consumption from public procurement, with the added benefits of cutting energy bills and greenhouse gas emissions.

- b) Power from weather-dependent renewables is highly variable on both daily and seasonal scales. Modelling by Imperial College which informed the illustrative 2050 scenario suggested an important role for interconnection, battery storage and flexible demand in a future low-carbon power system:
 - i. What other technologies could play a role here?
 - ii. What evidence do you have for how much demand side flexibility might be realised?

Question 31 (Hydrogen): The Committee has recommended the Government support the delivery of at least one large-scale low-carbon hydrogen production facility in the 2020s. Beyond this initial facility, what mechanisms can be used to efficiently incentivise the production and use of low-carbon hydrogen? What are the most likely early applications for hydrogen?

Question 32 (Aviation and Shipping): In September 2019 the Committee published advice to Government on international aviation and shipping and Net Zero. The Committee recognises that the primary policy approach for reducing emissions in these sectors should be set at the international level (e.g. through the International Civil Aviation Organisation and International Maritime Organisation). However, there is still a role for supplementary domestic policies to complement the international approach, provided these do not lead to concerns about competitiveness or carbon leakage. What are the domestic measures the

UK could take to reduce aviation and shipping emissions over the period to 2030/35 and longer-term to 2050, which would not create significant competitiveness or carbon leakage risks? How much could these reduce emissions?

Question 33 (Agriculture and Land use): In Chapter 7 of the Net Zero Technical Report we presented our Further Ambition scenario for agriculture and land use (see page 199). The scenario requires measures to release land currently used for food production for other uses, whilst maintaining current per-capita food production. This is achieved through:

- A 20% reduction in consumption of red meat and dairy
- A 20% reduction in food waste by 2025
- Moving 10% of horticulture indoors
- An increase in agriculture productivity:
 - Crop yields rising from the current average of 8 tonnes/hectare for wheat (and equivalent rates for other crops) to 10 tonnes/hectare
 - Livestock stocking density increasing from just over 1 livestock unit (LU)/hectare to 1.5 LU/hectare

Can this increase in productivity be delivered in a sustainable manner?

Do you agree that these are the right measures and with the broad level of ambition indicated? Are there additional measures you would suggest?

Question 34 (Agriculture and Land use): Land spared through the measures set out in question 33 is used in our Further Ambition scenario for: afforestation (30,000 hectares/year), bioenergy crops (23,000 hectares/year), agro-forestry and hedgerows (~10% of agricultural land) and peatland restoration (50% of upland peat, 25% lowland peat). We also assume the take-up of low-carbon farming practices for soils and livestock. Do you agree that these are the key measures and with the broad level of ambition of each? Are there additional measures you would suggest?
