Your request:

Specifically, I would like to know if any member of the Climate Change Committee has provided briefings (written or oral) to government officials and/or ministers, about the risks posed to the UK by climate tipping points.

Specifically, the tipping points I am most interested in are the collapse of the AMOC, changes to the North Atlantic jet stream, and collapse of the West Antarctic ice sheet. Please provide details of any briefings and subsequent correspondence.

This would apply to any written or oral briefing sent by CCC members between Jan 2021 and December 2022. It applies to both briefings on the risks posed by tipping points, and any advice offered about preparing the UK for adaptation to these threats.
