## Your request:

We would like to request information relating to communication and consultation between the Climate Change Committee (the "CCC") and Drax Group/Drax Power ("Drax"), in relation to the 6th Carbon Budget published on 09 December 2020. Please include the following:

- 1. Confirmation of whether there were any calls or meetings held between the CCC and employees or agents of Drax Group/Drax Power in the period of 01 January 2020- 09 December 2020 in relation to the 6th Carbon Budget. If so, please disclose how many meetings were held, the date of the meetings, the job descriptions of people present and the topic of the meeting. Please disclose agendas of the meetings and copies of any other documentation prepared in advance of or handed out during said call or meeting (for example, modelling or data that was discussed).
- 2. Correspondence between Drax and the CCC in 2020. For emails, please include the date and time of each email, and the job titles of everyone in the email chains, including people copied in.

## Our response:

Thank you for your request. We have handled your request under the Environmental Information Regulations (EIR) 2004. Please find our response below.

The information requested has been considered environmental information, given it covers measures (including administrative measures), such as policies, legislation, plans, programmes, environmental agreements, and activities affecting or likely to affect factors, such as substances, energy, noise, radiation or waste, including radioactive waste, emissions, discharges and other releases into the environment.

Under regulation 5(3), personal information from junior CCC staff and external contacts has been removed.

All relevant detail of any calls or meetings between the CCC and Drax Group/Drax Power employees in relation to the 6<sup>th</sup> Carbon Budget is set out in Table A, with additional documentation attached by email.

Your resource numbers, with the various sustainability filters, aligned really pretty well with CCC's 2018 Bioenergy report, which is the basis for our 6CB analysis. Although the global biomass numbers you showed didn't go as far as allocating a UK "fair share", which CCC need to assume to derive import availability (we're sticking with the same assumptions as in the 2018 work).

You mentioned that Frontier were doing some work for you, in terms of what support is required and what might be a credible BECCS rollout to 2040. Has this work completed?

## Hi Karl

Certainly, I'll take a look through the additional slides, and thank you for the presentation last week. For my part, it was particularly useful to test out our current biomass cost assumptions, and if you have a view on how UK or import costs may change over time, this would also be useful. I or my power sector colleagues (including [Name redacted]) may come back to you with questions in the coming weeks. One likely question would be a credible BECCS capacity ramp-up trajectory in the late 2020s/early 2030s, given that 12GWe won't happen by 2030.

I also note that CCC have publically said at several stakeholder events that we are no longer using "Core", and our 6<sup>th</sup> carbon budget work is going beyond the 96% reduction in "Further Ambition", to instead achieve 100% reductions in three scenarios by 2050 (or earlier). This may help with your/McKinsey's prioritisation and framing.

We're always open to receiving high quality evidence on what policy frameworks may be required in order to get deployment to occur, so we would be happy to schedule a further call in a few weeks.

- Mapping biomass supply 'hot spots' with CO<sub>2</sub> storage capacity globally to identify geographies where BECCS may deploy more rapidly than others.

As we mentioned on the call, we are in the process of finalising a piece of work with Frontier Economics outlining what a BECCS policy framework looks like in the 2020s, and how it could evolve over the 2030s and 2040s to promote competition between BECCS projects and subsequently all GGR solutions. Hopefully this will help the work you and colleagues are doing on policy aspects of the 6CB. We'll circle back in a few weeks when we're in a position to share, with a view to scheduling in another call to talk through?

Apologies for the delay in coming back to you. In response to your points:

- Carbon pricing: thanks for confirming, for the reasons discussed previously (carbon neutrality of biomass) can you confirm that this will be removed from the LCOE?
- 2. Opex: Our £55m opex figure does not include T&S costs. The £55m is based on the  $\sim$ £30m opex associated with operating a biomass power plant, based on our experience running the units at Drax in recent years, and  $\sim$ £25m opex for the capture plant.
- 3. T&S costs: Wood Group assumes biomass emissivity at 1.38/tCO2 per MWh of biomass (£26.2/MWh / £ 19/tCO2) leading to a higher concentration of CO2 per MWh produced. In contrast our assumed biomass emissivity is 0.93/tCO2 per MWh, leading to a lower T&S cost of ~£18/MWh.

Hi Karl,

Thank you for taking the time to walk me through the CCC/Drax cost comparison last week, I found that very helpful.

As discussed, I have been doing a little digging into our own numbers again to make sure you have the right figures. I just wanted to give you an update on that:

- Last week, I suggested we had not included a carbon price, which was wrong. I had a chance to chat with [Name redacted] who sent the data to McKinsey and I can confirm that the levelised costs of £173/MWh does include a carbon price of £11.7/MWh.
- We indeed also assume £140m per annum in operating costs. However, that includes £78.5m a year in CCS transport and storage costs. Am I right in understanding that the £55m per annum you suggest includes these costs? If not, the difference in our assumptions should not be significant.
- In addition, we already use a £19/tCO2 for CCS transport and storage costs. Would you mind explaining how you have reached £17/MWh in T&S costs? Could you outline the underlying assumptions? To some extent, there should be a difference in our estimates given that we assume a 95% capture rate, but it should not be that significant.

For my part, I am still working on the fuel price assumptions, but we should be able to update you next week.

In early April a group from Drax and McKinsey presented to [Name redacted] and [Name redacted] Taylor a new piece of analysis we are due to publish in the coming weeks on BECCS costs, reviewing the CCC's cost estimate in the Net Zero report and revising it down through a number of cost-downs based on assumptions we believe better reflect real-life technology choices and plant performance. I've attached the slide pack as presented then.

The affect of the revisions is to bring the cost of BECCS down from £158/tCO2 MAC plus wholesale power to  $\sim$ £97/tCO2 plus wholesale power. This would I believe result in a revised LCOE of  $\sim$ £142/MWh vs. the  $\sim$ £173/MWh you had listed in your slide deck for the planned CB6 modelling runs.

We'd be very happy to talk you and the team through this again, if helpful. I'm away next week but have copied in my colleagues [Name redacted] and [Name redacted].

In the meantime I am also going to approach [Name redacted]'s team as we have done a related piece of work with McKinsey on global biomass availability, which is relevant to this discussion.

In the meantime, we published a lot of additional material alongside the main CB6 reports and I think most of the answers you're after can be found buried in these:

- Charts and data file This has a more detailed breakdown of the BECCS costs over time (link).
- Removals summary This brings together all the removals parts of the three main reports into one place, and explains the role of BECCS in our scenarios (<u>link</u>). There's also one for power (<u>link</u>). In general BECCS is deployed at a rate depending on the requirement for removals in the scenario, and taking into account the relative costs of that (against other options in each sector, and between different uses of biomass).
